

1. There is deficit of Rs.25,09,964.87 /-, for the year under audit as against the deficit of Rs.22,29,694.13 /-. The increase in deficit for the Current year is on account of decrease in the Fees collection.

2. The outstanding Credit/Debit balances appearing on the Balance Sheet as on 31st March 2020 are long outstanding for adjustments. Necessary steps should be taken to recover /pay the said amount or suitable adjustments be effected in the books.


